

Continuous Brewing Tradition:

U Fleků is one of the few breweries in Central Europe that has been brewing beer continuously for over 500 years. Despite being nationalized during the communist era, the original owners, the Brtník family, regained control of the brewery and restaurant in 1991 after the fall of the regime1.
